ORDER

WHEREAS, Katwa College, At/Po- Katwa, Dist-Burdwan, West Bengal-713130 (APE00432) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2008-2009 vide ERC order dated 30.08.2008, followed by revised recognition order issued on 27.05.2015 with an intake of 50 (one basic unit) from the academic session 2015-2016 as per NCTE Regulation, 2014.

2. **AND WHEREAS,** the ERC in its 275th meeting held on 26th July, 2019 considered the matter and as decided, recognition granted to B.Ed. course was withdrawn u/s 17(1) vide order no. 61464 dated 02.09.2019 from the academic session 2020-2021 to the institution.

3. **AND WHEREAS,** the institution preferred an appeal to NCTE HQs. against the ERC's order dated 02.09.2019 The Appellate Authority vide order No.89-420/E-139388/2019 Appeal/37th Mtg.-2019/27th November, 2019/86545 dated 23/12/2019 remand back the case to ERC with a direction to consider the documents to be submitted to them by the appellant and take further action as per the NCTE Regulations, 2014. The appellant is directed to forward to the ERC the documents submitted in appeal, with originals thereof, wherever necessary, within 15 days of receipt of orders on the appeal.

4. **AND WHEREAS,** the institution has submitted representation vide letter dated 30.12.2019 received in this office on 02.01.2020. The ERC in its 279th meeting held on 14th - 16th February, 2020 considered the matter and as decided, Show Cause Notice was issued on 28.02.2020 to the institution.

5. **AND WHEREAS,** the institution has submitted reply vide letter dated 16.03.2020 received in this office on 19.03.2020. The ERC in its 282nd meeting held on 8th - 9th July, 2020 considered the matter and as decided, Final Show Cause Notice was issued on 22.07.2020 to the institution on the following grounds:

- (i) List of teaching faculty duly approved by the concerned affiliating body in the NCTE prescribed proforma to be submitted.

6. **AND WHEREAS,** the institution submitted reply vide letter dated 20.07.2020 & 13.08.2020 received in this office on 31.07.2020 & 20.08.2020. The original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by ERC in its 283rd meeting held on 24th & 25th August, 2020 and the committee decided as under:-
